Subject: Your application for access to documents – Ref GestDem No 2014/861

Dear Mr Mclaren

We refer to your e-mail dated 17/02/2014 in which you make a request for access to documents, registered on 17/02/2014 under the above mentioned reference number. We further refer to our holding reply of 07/03/2014 extending the deadline for reply to 3/03/2014.

Your application concerns: "All correspondence that the Smokefree Partnership; the European Public Health Alliance; the European Respiratory Society; Action on Smoking and Health and the British Medical Association have had with the European Commission on the subject of nicotine containing products (as defined in COM(2012)788) and electronic cigarettes between January 2012 and December 2013&quot".

We have identified the documents concerned (see Annex I) and consulted their authors, in accordance with Article  $4(4)^{I}$  of Regulation (EC) No  $1049/2001^{2}$  on public access to documents. We are now in a position to send you these documents.

Having examined the documents requested under the provisions of Regulation (EC) No 1049/2001 regarding public access to documents, I have come to the conclusion that they may be partially disclosed. Please note that some of them have been expunged of personal data pertaining to third parties and Commission officials of non-managerial posts, as indicated in Annex I.

Pursuant to Article 4(1) (b) of Regulation (EC) No 1049/2001, access to a document has to be refused if its disclosure would undermine the protection of privacy and the integrity of the individual, in particular in accordance with Community legislation regarding the protection of personal data. The applicable legislation in this field is Regulation (EC) No 45/2001 of the European Parliament and of the Council of 18 December 2000 on the protection of individuals with regard to the processing of personal data by the Community institutions and bodies and on the free movement of such data<sup>3</sup>.

According to that provision, "As regards third-party documents, the institution shall consult the third party with a view to assessing whether an exception in paragraph 1 or 2 is applicable, unless it is clear that the document shall or shall not be disclosed."

When access is requested to documents containing personal data, Regulation (EC) No 45/2001 becomes fully applicable<sup>4</sup>. According to Article 8(b) of this Regulation, personal data shall only be transferred to recipients if they establish the necessity of having the data transferred to them and if there is no reason to assume that the legitimate rights of the persons concerned might be prejudiced.

We consider that, with the information available, the necessity of disclosing the aforementioned personal data to you has not been established and that it cannot be assumed that such disclosure would not prejudice the legitimate rights of the persons concerned. Therefore, we are disclosing the documents requested expunged from this personal data.

In accordance with Article 7(2) of Regulation 1049/2001, you are entitled to make a confirmatory application requesting the Commission to review this position.

Such a confirmatory application should be addressed within 15 working days upon receipt of this letter to the Secretary-General of the Commission at the following address:
