This includes measures on monitoring, reporting, verification (MRV), leak detection and repair (LDAR) and restrictions on routine venting and flaring (BRVF). In responding to this request, the Commission need not provide that information which was submitted during public consultation and then subsequently made publicly available on the following portal"
