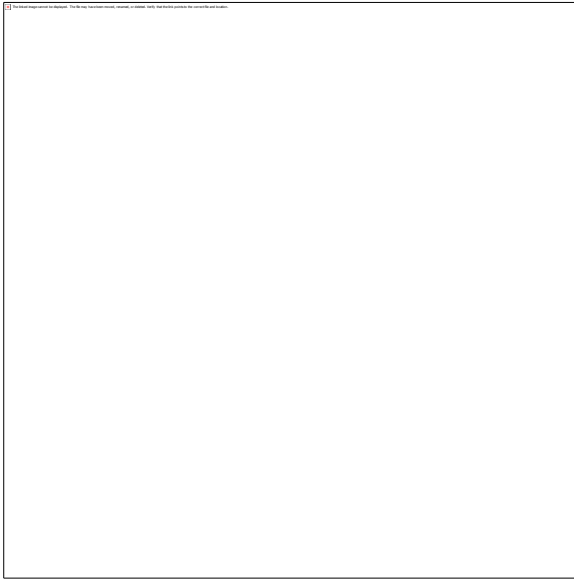
Our Deputy Head of Cabinet, Stephanie Riso, and Ambassador Tim Barrow are in close contact concerning further arrangements with regards to this call.
