Subject: Your application for access to documents – GESTDEM 2022/1567

We refer to your e-mail of 16 March 2022 in which you make a request for access to documents, registered on 17 March 2022 under the above-mentioned reference number.

In particular, you request access to *“All documentation, including but not limited to attendance lists, agendas, background papers, minutes/notes, video recordings and email correspondence about or summarising, the following meetings:*

1. Conference call between Filip Alexandru and Negreanu Arboreanu with ExxonMobil Petroleum & Chemical on 16/03/2022 regarding the fit for 55 package”.

We consider your request to cover documents held up to the date of your initial application, i.e. 16 March 2022.

We regret to inform you that the Commission does not hold any documents that would correspond to the description given in your application. The reason for this is that there were no documents exchanged prior to or during this meeting.

As specified in Article 2(3) of Regulation (EC) No 1049/2001 regarding public access to European Parliament, Council and Commission documents¹ (hereinafter ‘Regulation (EC) No 1049/2001’), the right of access as defined in that regulation applies only to existing documents in the possession of the institution.

Given that no such documents, corresponding to the description given in your application, are held by the Commission, this Commission is not in a position to fulfil your request.
