Dear colleagues,

please be informed that Slovakia agrees with disclosure of the concerned document. However, the Ministry of Health requested that I should communicate to you, together with our consent, also the following note from an expert responsible for the subject:

"In the statistics, the figure given concerning the number of certificates issued on the basis of RAT tests was in the morning of 28.2.2022 as of 8:00 a.m. actually reported in the amount of 4,316,257 units. Subsequently, in the next statistical report of 4.3.2022, this figure was corrected back to 4,167,909 pcs. So the correct data on the morning of 28.2.2022 to 8:00 am should be:

Vaccination certificates: 6 619 074
NAAT/ PCR test certificates: 3 470 221
RAT test certificates: 4 167 909
Recovery certificates: 1 153 544
Total certificates issued: 15 410 748

According to this correction dated 4.3.2022, I subsequently corrected our statistics on the EC website, where the current figures are published. Should the aforementioned error and its repair cause any problem, we will be happy to answer the EC's questions. Subsequently, in the following months, data from various other related IT systems were further consolidated, which were not yet included in the statistics on 28.2.2022, but the statistics were not retrospectively corrected. So today maybe the statistics on 28.2.2022 would look a little different again. It should therefore be stressed that on the published document there are figures that were valid as of 28.2.2022 at 8:00 a.m."
