I refer to your e-mail of 4 October 2022, registered on 5 October 2022, in which you submitted a confirmatory application in accordance with Article 7(4) of Regulation (EC) No 1049/2001 regarding public access to European Parliament, Council and Commission documents¹ (hereinafter 'Regulation (EC) No 1049/2001').

Your confirmatory application was submitted in relation to your initial application of 11 April 2022, in which you requested access to, I quote:

The processing of your initial application was assigned to the European Commission's Directorate-General for Energy.

As you did not receive an initial reply within the statutory time limits, you submitted a confirmatory application on 4 October 2022.

In the meantime, the initial reply in question was sent to you on 3 January 2023 (under reference number Ares(2023)20538).

Against this background, the Secretariat-General will close your confirmatory application related to the lack of initial reply.

You remain entitled to submit a confirmatory application in accordance with Article 7(2) of Regulation (EC) No 1049/2001, should you wish to request a review of the initial reply of 3 January 2023.
