Stresses that the world's growing instability *and confrontational environment* (AM 76, AM 81), *the erosion of multilateralism* (AM 85, 76) and the rise of *authoritarianism* (AM 75), *as well as multifaceted* (AM 76) global challenges, especially *the increasing climate of conflict* (AM 81) *which translates into the continuation and sometimes resumption of armed conflicts* (AM 76, AM 78) *including at the Eastern and Southern borders of the European continent* (AM 80, AM 86), *terrorism* (AM 78, AM 80, AM 81, AM 82, AM 83, AM 84), , climate change and *increasing threats to natural resources* (AM 80); *uncontrolled migration flows* (AM 80, 82, 83), health-related risks, *hybrid threats* (AM 87, 88) *such as disinformation campaigns, active measures* (AM 89) and cyberattacks, *among others* (AM 76), should lead the EU to *develop its*

*strategic autonomy* (AM 76) *while strengthening cooperation with its allies* (AM 78); in this respect, underlines the importance for the Union to establish more strategic *cooperation* (AM77) *with third countries based on trust and mutual benefit* (AM 74), alliances with like-minded democracies *including from the Southern Hemisphere* (AM 77) *and to build ad hoc coalitions with other like-minded* (AM 77) partners where necessary;

Expresses concerns at the unprecedented scale of state-sponsored disinformation campaigns, the manipulation and weaponisation of information, including by state actors with malign intentions; *welcomes the quick response by the EU institutions to this new challenge, such as the setting up of a new special committee in Parliament focusing on foreign interference in democratic processes in the EU, including disinformation;*

5. Expresses concerns at the unprecedented scale of *state and non* (AM 115) state-sponsored disinformation *and propaganda* (AM 112) campaigns, *which have devastating effects on societies* (AM 119), *including in the European neighbourhood and in particular in the Western Balkans*; (AM 110) *condemns* the manipulation and weaponisation of information, including by state, *sub-state* (AM 109) *and non-state* (AM 114) actors with malign intentions, including *platforms and organisations used by authoritarian third countries to directly and indirectly finance and influence Europe's political parties and political actors* (AM 109); welcomes the *much-needed* (AM 108) response by the EU institutions to this new challenge, such as setting up a new special committee in Parliament focusing on foreign interference in democratic processes in the EU, including disinformation *and the adoption of the Council decision concerning restrictive measures against cyber-attacks threatening the Union or its Member States* (AM 90); *stresses the need for a response which does not limit fundamental rights and freedoms*; (AM 106); *points out the importance of effective EU strategic communication and commends the strengthening of Stratcom within the EEAS and its efforts to identify and suppress disinformation campaigns* (AM 109, 110, 111); *highlights the need for the EU to further strengthen its capacities to proactively combat fake news and disinformation as a threat to democracy, and to improve its security culture in order to better protect its information and communication networks* (combination AM 112, AM 116, AM 117, AM 118, AM 123); *calls on the EU to become a frontrunner in advocating for a collective self-defence and cooperation framework against hybrid threats and the malign influence of authoritarian regimes in particular on democratic governance and private enterprises globally* (AM 121); *stresses therefore the need for the EU to strengthen its alliances with other global democratic actors to confront such*

Insists that the EU's foreign and security policy should be guided by the promotion of democracy, the protection of human rights and the promotion of fundamental freedoms, including the freedom of religion or belief, **and Christians' rights**; welcomes in this respect the recent Commission decision to renew the mandate of the Special Envoy for the promotion of freedom of religion or belief outside the EU;

6. Insists that the EU's foreign and security policy **must** (AM 130) be guided by the promotion of **Article 21 TEU objectives such as** (AM 132) democracy, **human dignity** (AM 128), human rights and fundamental freedoms, including the freedom of religion or belief, **the protection of all minorities and of religious communities, including Christians, Jews, Muslims, non-believers and others** (AM 127, AM 131, AM 140; AM 141, AM 142,) and the promotion of **gender equality** (AM 133); welcomes in this respect the recent Commission decision to renew the mandate of the Special Envoy for the promotion of freedom of religion or belief outside the EU but **urges an appointment to happen as soon as possible** (AM 129, 138); **calls on EU delegations to closely monitor the global human rights situation, identify trends and support citizens and civil society organisations in their efforts to reverse the negative trend on human rights worldwide** (AM 144 shortened) ; **stresses that the EU's foreign and security policy is more effective through the use of conditionality in its economic and political incentives; reminds in this regard that the Commission should monitor and report regularly to the European Parliament regarding the human rights situation in the third countries beneficiary of the visa waiver and should suspend the visa exemption in case of violations in the country concerned** (AM 143, shortened); **calls on the Commission and the Council to strengthen the Union's democracy support programmes globally by fostering pro-democratic bottom-up processes,**

*building institutional resilience* (AM 146) *and to support the work of European political foundations in strengthening democratic processes* (AM 146 and 147, shortened); *calls for a reform and review of the EU Special Representatives and Special Envoys as called for by the European Parliament in its recommendation from March 2019* (AM 139);

8. Reiterates its call for a revision of the EU Global Strategy in order to draw the lessons from the new geopolitical dynamics, current threats *including the COVID-19 pandemic* (AM 162) and expected upcoming challenges, and to reassess the goals and means of the CFSP; highlights *that while further developing its cooperation with international partners and allies* (combination of AMs 160, 161) the EU *has to speed up decision-making in foreign affairs, the EU's ability to work with like-minded partners while strengthening multilateralism and to strengthen its strategic capacities to act, also autonomously if needed* (AM 159); *has a responsibility to forge* (AM 157) its strategic autonomy *on common diplomacy, security, and defence issues as well as on* (AM 163, AM 157) economic, *health* (AM 162) and trade matters, *in order to address the many shared common challenges* (AM 157) to defend its interests, *norms* (AM 159) and values in the post-pandemic world, *stresses, therefore, the need for European countries to retain the capacity to take decisions and to act alone* (AM 157) ; *urges Member States to swiftly implement and apply the new regulation to establish mechanisms for screening foreign investments in critical sectors* (AM 165); *encourages EU Member States to create a new forum for multilateral cooperation, drawing on the legacy of the Coordinating Committee for Multilateral Strategic Export Controls, to monitor and control export of technologies, trade flows and sensitive investments to countries of concern* (AM 165);
