The European Commission (DG FISMA) is organising a **FORUM to discuss the regulatory framework protecting and facilitating investment in the EU** with stakeholders and Member States. The event will take place in a hybrid format on 28 June 2022 in Brussels. The provisional agenda is attached to this invitation (speakers to be confirmed).

The 2022 FORUM has the following objectives:

Presentation of the policy approach and a toolbox of possible targeted measures on investment protection and facilitation by Commissioner McGuinness.

Discussing how to ensure effective implementation of the measures, including optimising feedback channels and follow-up mechanisms to deal with investment protection issues of single market concern.

The FORUM will bring together all stakeholders and encourage exchanges of views in a roundtable format. The participants will include companies and investor associations from various sectors, legal practitioners, academics, civil society organisations, Member States authorities as well as Commission officials.

Following also the Technical support project on the impact of regulations on international investment in Finland concluded one year ago (supported by DG REFORM), we would like to invite Business Finland to participate as speaker in this event. More specifically we would like you to participate in **Panel 3**, which will show the ways of making investments in the EU easier with a focus on investment facilitation measures for sustainable investment. It will present and discuss measures that have been put in place at EU level, as well as national investment promotion and facilitation initiatives.

The deadlines are short and we would like confirmations from the potential speakers by **22 April**. We would be grateful if you could confirm your participation as a speaker on the event before that date.
