Dear Mr Moritz Neujeffski,

We refer to your request of 8 September 2022, registered on 12 September 2022 under the above-mentioned GestDem reference number. Your request concerns access to the following documents:

- 1. All comments provided to the Commission by stakeholders concerning incoming notifications regarding services, since March 1st 2021.
- 2. Internal communication from the Commission and assessments of notified measures and their compatibility with the Services Directive¹, since March 1st 2021.

Furthermore, following your answer submitted to the Commission's request for further clarification regarding the scope of your request, the scope of your request was extended to the following documents:

3. Reactions of the Commission delivered to Member States within the framework of the notification procedure established by the Services Directive.

Concerning the documents falling under point 3, we identified 21 documents containing reactions of the Commission delivered to Member States pursuant to measures notified under the Services Directive. Having analysed your request in the light of Regulation (EC) No 1049/2001 regarding public access to European Parliament, Council and Commission documents, we consider access to the requested documents can be granted.

Please note that, as far as the disclosed Commission documents are concerned, you may reuse them free of charge for non-commercial and commercial purposes provided that the source is acknowledged and that you do not distort the original meaning or message of the document. Please note also that the Commission does not assume liability stemming from the reuse.
