As the EU puts the decarbonisation of industry at the centre of its strategy to reach a fair and climate neutral Europe, I am pleased to inform you that [REDACTED] and [REDACTED] have agreed to develop a CO2 infrastructure project for large-scale decarbonisation in North-Western Europe.

The project includes an onshore open-access CO2 transmission infrastructure operated by [REDACTED] in Belgium, connected to a 1,000 km CO2 export trunkline operated by [REDACTED] which will transport CO2 from emitters in Belgium and surrounding countries for safe and permanent storage under the seabed on the Norwegian continental shelf.
