I represent the European technology company Village Data Analytics (VIDA) and am reaching out to you, because I believe that our work in developing countries, especially in Africa, supports the goals of the EU in international partnerships / Africa, and is worthy of your support. Like you, we also believe in a balanced, intensified and innovative partnership with Africa.

With VIDA, we provide the digital infrastructure to channel investments into physical infrastructure linked to the Sustainable Development Goals. This could be energy access, access to healthcare, education, water/agriculture, and others.
