Since we understand that the Commission should be sending comments to the Spanish National Recovery and Resiliency Plan by the end of this month we would very much appreciate your support in taking these factors into consideration to suggest a broader approach in the funding of the transition from 4G to 5G than the pure replacement of "non functional" 4G which is a much more blurry and difficult standard to be defined.
