As at 09 June 2022, for this budget heading no costs are recorded as having been spent or committed, with the exception of budget line 1.2.2 Grant (Sub-delegation agreement) to CIHEAM Bari.

On 18 March 2022, a sub-delegation agreement was signed between AICS and CIHEAM Bari. The expected duration is 27 months, the total amount is EUR 3,350,000 and the implementation starting date is 21 March 2022. The planned duration of this agreement was initially 33 months but was reduced to 27 months as the negotiation between AICS and CIHEAM Bari took longer than expected. The total budget was reduced accordingly, from EUR 3,692,438 to EUR 3,350,000, and the positive balance of EUR 342,438 will be reallocated from budget item 1.2.2 *Grants (Sub-delegation agreement) to CIHEAM Bari* to budget item 1.2.1 *Grants to NGO Partners / Service Contracts* in the same budget heading. This shift will be reported in the financial table when there will be a financial effect with the signing of the Grants with the NGO Partners. During the reporting period, EUR 700,000 were disbursed on 25 April 2022 as the first pre-financing instalment.

Budget Line 3.1.1 International Personnel

The following are the international staff employed during the reporting period

- <u>Team Leader/Programme Technical Coordinator:</u> The team leader's contract begins from 18 October 2021 until 30 March 2021 and its cost was split 50/50 between phase 1 (RSSD1 T05.437) and phase 2 (RSSD2 T05.1849). The total cost spent under Phase 2 is EUR 43,581.30.
- Senior Programme Officer (Deputy Team Leader): After the recruitment process, the contract started on 04 November 2021 with a duration of 12 months. From May 2022 the cost is split between Phase 1 (RSSD1 T05.437) and Phase 2 (RSSD2 T05.1849), covering respectively 30% and 70% of the total cost, until 30 June 2022. The total cost under Phase 2 (RSSD2 T05.1849) is EUR 122,140.84, of which EUR 66,097.47 spent and EUR 56,043.37 committed.
- Administrative and Financial Manager: From 14 October 2021 until 30 June 2022, the cost of the Administrative and Financial Manager was shared 50/50 between Phase 1 (RSSD1 T05.437) and Phase 2 (RSSD2 T05.1849). The total cost under Phase 2 is EUR 84,911.67 of which EUR 39,169.15 spent and EUR 45,742.52 committed.
- Administration/Procurement Officer: After the recruitment process, the contract started on 15 February 2022 with a duration of 12 months and is entirely under Phase 2 (RSSD2 T05.1849). The total cost of the contract is EUR 72,181.78 of which EUR 15,538 spent and EUR 56,643.78 committed.
- The consultant for the dedicated management of the PMU team international staff was contracted at a cost of 621,71.

During the reporting period an HR company was selected to manage the consultants for the finalisation of the needs assessment. The contract total cost is 17,386 of which EUR 7,260 was spent and EUR 10,126 committed as at 09 June.

Budget Line 3.1.3 Travel and subsistence costs

EUR 2,990 was spent during the reporting period. A tender procedure was launched to identify the economic operator to whom the service will be entrusted for the Team's travels and transfers.

Budget Line 3.1.4 Project office costs

Two offices were rented for PMU staff, one in Tunis and one in Tripoli.

The Tunis office has one room at the Tunis Business Center with 3 workstations; EUR 2,790.36 was spent and EUR 12,245.54 committed as at 09 June.

The office in Tripoli is in 50 per cent cost sharing between Phase 1 and Phase 2. Under Phase 2, EUR 15,000 was committed and EUR 3,798.48 was spent for stationery or bank fees.

Budget Line 3.1.5 Equipment and supplies

EUR 19,173.16 was spent to purchase computer equipment, namely 3 lap tops with licences, 1 satellite Link and 1 printer.

- <u>Programme Officer (Coordination of Technical Secretariat):</u> After the recruitment process, the contract started on 02 May 2022 with a duration of 12 months and is entirely under Phase 2 (RSSD2 T05.1849).
