I am writing to you on behalf of [REDACTED], Head of Regulatory Anticipation at Compañía Espanola de Petróleos S.A. (CEPSA), to request a meeting.

CEPSA is a leading energy company with businesses across five continents that is committed to taking the necessary climate actions to accelerate the energy transition and move towards a low-carbon economy. CEPSA plays a leading role in this transition through the Positive Motion Strategy, which goes beyond reducing to zero net greenhouse gas emissions to make additional “positive” contributions to the environment.

CEPSA welcomes the Commission’s proposal for a Regulation on an emergency intervention to address high energy prices and introducing a EU solidarity contribution of ‘fossil companies’.

In this regard, [REDACTED] would like to address some concerns that CEPSA has on the proposal for Regulation to ensure that it strikes the correct balance between the protection of immediate societal needs and the potential of companies to contribute to the achievement of energy and environmental objectives.
