Please find attached a partially accessible version of document **WK 17962/22**.² However, I regret to inform you that full access cannot be given for the reasons set out below.

The General Secretariat of the Council has examined your request on the basis of the applicable rules: Regulation (EC) No 1049/2001 of the European Parliament and of the Council regarding public access to European Parliament, Council and Commission documents (OJ L 145, 31.5.2001, p. 43) and the specific provisions concerning public access to Council documents set out in Annex II to the Council's Rules of Procedure (Council Decision No 2009/937/EU, OJ L 325, 11.12.2009, p. 35).

Document WK 17962/23 is a flash note from the Council Presidency to Member States' delegates in the Council Working Party on Consumer Protection and Information (Consumer Credits) dated 4 January 2023, i.e. at the beginning of its mandate, explaining the organisation of work regarding the Consumer Credits Directive.

The document also contains personal data of identified members of the Presidency team. The personal data contained in this document are necessary for the organisation of the work of the Council.

The EU data protection rules³ provide that when the personal data collected is to be used for a different purpose, including disclosure to the public, a balance needs to be established between the public interest in having access to such data and the legitimate right of individuals to protect their personal data.⁴

After carefully considering all the principles related to this request, on balance the General Secretariat has concluded that disclosure of the personal data contained in the document would undermine the protection of privacy and the integrity of the identified individuals. As a consequence, the General Secretariat has to refuse full access to this document.⁵

Pursuant to Article 7(2) of Regulation (EC) No 1049/2001, you may ask the Council to review this decision within 15 working days of receiving this reply. Should you see the need for such a review, you are invited to indicate the reasons thereof.

The General Secretariat is still conducting consultations necessary to the examination of documents **WK 4366/22**, **WK 17827/22**, **WK 1034/23**, **WK 1445/2023**. Therefore, we have to extend the deadline for reply to your request regarding these documents by 15 working days, until 20.04.2023.⁶
