Having examined the documents requested under the provisions of Regulation (EC) No 1049/2001 (3) regarding public access to documents, I have come to the conclusion that

- documents 7.1, 8.1, 9.1, 13.1, 14.1, 24–41.1, 60–77 and 78.1 can be fully shared with the public,
- documents 1–7, 8, 9, 10–13, 14, 15–23.1, 78, 78.2, 78.3,79 and 79.1 may be partially disclosed,
- no public disclosure is possible regarding documents 42–59.

My detailed assessment is set out below.

#### I. Full disclosure

Please find attached documents 7.1, 8.1, 9.1, 13.1, 14.1, 24–41.1 and 78.1.

With regards to the identified documents 60–77 please note that in line with Article 49(1) of the Common Provision Regulation (<sup>4</sup>), "[t]he managing authority shall ensure that, within 6 months of the decision approving the programme, there is a website where information on programmes under its responsibility is available, covering the programme's objectives, activities, available funding opportunities and achievements".

In the cases of Cyprus (AMIF and BMVI), Hungary and Poland (for the three funds), please note that at the time of the submission of your request, the Horizontal Enabling Condition on

the effective application and implementation of the Charter of Fundamental Rights were not considered fulfilled from the European Commission.

#### II. Partial disclosure

As regards documents 1–7, 8, 9, 10–13, 14, 15–23.1, 78, 78.2, 78.3, 79 and 79.1, some of their parts have been blanked out as their disclosure is prevented by exceptions to the right of access laid down in Article 4(1)(b) of Regulation (EC) No 1049/2001 (protection of the privacy and the integrity of individuals) and Article 4(2) of this Regulation (protection of legal advice). In addition, many parts of those documents have been redacted as falling outside of the scope of the submitted request.

#### **Protection of personal data**

With regards to the identified documents 1–7, 8, 9, 10–13, 14, 15–23.1, 78, 79 and 79.1, their complete disclosure is prevented by the exception concerning the protection of privacy and the integrity of the individual outlined in Article 4(1)(b) of Regulation (EC) No 1049/2001, because they contain the following personal data:

- The names/ initials and contact information of Commission staff members not pertaining to the senior management;
- The names/initials and contact details of other natural persons;
- Handwritten signatures/abbreviated signatures of the natural persons.

In accordance with Article 4(1)(b) of Regulation (EC) No 1049/2001, "[t]he institutions shall refuse access to a document where disclosure would undermine the protection of [...] privacy and the integrity of the individual, in particular in accordance with Community legislation regarding the protection of personal data".

Article 9(1)(b) of the Data Protection Regulation (<sup>5</sup>) does not allow the transmission of these personal data, except if you prove that it is necessary to have the data transmitted to you for a specific purpose in the public interest and where there is no reason to assume that the legitimate interests of the data subject might be prejudiced. In your request, you do not express any particular interest to have access to their personal data nor do you put forward any arguments to establish the necessity to have the data transmitted for a specific purpose in the public interest.

Consequently, I conclude that, pursuant to Article 4(1)(b) of Regulation (EC) No 1049/2001, access cannot be granted to the personal data contained in the requested documents, as the need to obtain access thereto for a purpose in the public interest has not been substantiated and there is no reason to think that the legitimate interests of the individuals concerned would not be prejudiced by disclosure of the personal data concerned.

## > Protection of legal advice

Parts of documents 78.2 and 78.3 contain preliminary opinions of the Commission's Legal Service, which are sensitive as they remain relevant for the continuous monitoring of the situation in Member States. These documents relate to hypothesis likely to occur under the

2021-2027 programming period and on which the College may still be called upon to take a decision.

In accordance with the second indent of Article 4(2), "[t]he institutions shall refuse access to a document where disclosure would undermine the protection of [...] legal advice [...]".

I consider that disclosure of these preliminary opinions of the Legal Service would undermine the institution's interest in seeking and receiving frank, objective and comprehensive legal advice. Disclosure would make known the internal opinions and guidance of the Legal Service on this very complex and highly sensitive matter, at a time when the Commission is still monitoring the fulfilment of the enabling conditions in relation to several Member States and it is unavoidable that future Commission decisions will be taken on that matter.

The exception laid down in Article 4(2) of Regulation (EC) No 1049/2001 apply unless there is an overriding public interest in disclosure of the document. I observe that you have not provided any arguments in your initial application to support any pressing need for the public to obtain access to the documents. I have also examined whether there could be an overriding public interest in disclosure, but I have not been able to identify such an overriding interest.

In light to the above, I consider that the exception of Article 4(2) of the Regulation (EC) No 1049/2001 applies to parts of documents 78.2 and 78.3.

As a result, please find enclosed documents 1–7, 8, 9, 10–13, 14, 15–23.1, 78, 78.2, 78.3, 79 and 79.1 in a redacted format, from which the protected or out of scope information has been removed.

#### Disclaimers:

#### III. Refusal

Documents 42–59 contain the preliminary versions of the programmes submitted by Member States to the Commission in accordance with Article 21(2) of the Common Provisions Regulation, which were then subject to the procedure set out in paragraphs 2 and 3 of Article 23 of the Common Provisions Regulation.

In accordance with the second subparagraph of Article 4(3) of Regulation (EC) No 1049/2001, "[a]ccess to a document containing opinions for internal use as part of deliberations and preliminary consultations within the institution concerned shall be refused even after the decision has been taken if disclosure of the document would seriously

undermine the institution's decision-making process, unless there is an overriding public interest in disclosure".

I consider that disclosure of the preliminary versions of these national programmes would undermine the protection of the decision-making process of the Commission, as it would reveal information submitted by the respective Member States to which the European Commission, provided observations and ended up to the final adoption of the Home Affairs Funds programmes of the Member States. The Commission services must be free to explore all possible options in preparation of their observations, free from external pressure. Therefore, the exception laid down in the second paragraph of Article 4(3) of Regulation (EC) No 1049/2001 applies to these documents.

I have considered whether partial access could be granted but for the abovementioned reasons, the documents cannot be partially disclosed.

The exceptions laid down in Article 4(3) of Regulation (EC) No1049/2001 apply unless there is an overriding public interest in disclosure of the document. I have examined whether there could be an overriding public interest in disclosure but have not been able to identify such an interest.

#### IV. Means of redress

In accordance with Article 7(2) of Regulation (EC) No 1049/2001, you are entitled to make a confirmatory application requesting the Commission to review this position.

Such a confirmatory application should be addressed to the Secretariat-General of the Commission within 15 working days upon receipt of this letter. You can submit it in one of the following ways:
