**Subject: Commission Observations on the Greek AMIF programme 2021-2027, CCI: 2021EL65AMPR001**

Your Excellency,

A complete<sup>1</sup> version of the Greek AMIF programme was formally submitted via SFC2021 on 15 December 2021. In accordance with Article 23(1) and (2) of the Common Provisions Regulation<sup>2</sup>, the Commission has assessed the programme and made some observations. These observations are set out in the annex.

As concerns the Horizontal Enabling Condition 3 on the *Effective application and implementation of the EU Charter of Fundamental Rights*, the Greek authorities will receive soon the Commission's comments by a separate letter.

We would like to ask your authorities to consider these observations and revise the programme accordingly, as well as to provide additional information wherever requested. Please bear in mind that, in accordance with Article 3 of the Common Provisions Regulation, where a time limit is set for an action by the Commission, that time limit is suspended from the day following the date on which the Commission sends its observations or a request for revised documents to the Member State and until the Member State responds to it.
