Event structure

The event will kick off at 17:00, I'd advise that Mr Hololei joins us 15 mins in advance (if possible of course). This will give [REDACTED] and Mr Hololei time to share any last minute additions/specifics/requests as part of their statements and will allow us to run through what we expect to happen one last time (to avoid any surprises for our guest of honour).

Once the room has filled up, we will grab everyone's attention, [REDACTED] will welcome everyone and give the floor to Mr Hololei – both speakers will be given a microphone in advance, no need for a presentation unless Mr Hololei insists on having one and we'd advise on a speech/statement of 15 mins or less.

Mr Hololei's statement will be followed by an unscripted late afternoon/early evening of socialising with the over 120 members of Europe's aviation, defence and tech communities that have currently registered.

Topics of interest

Given the audience, some of the topics that we foresee to be of interest include:

1. Sustainability - the European Commission's flight plan for sustainable aviation towards our shared goal of reaching Net Zero;
 2. EU-US renewed cooperation around certification and regulatory harmonization – where does the Commission stand on this;
 3. How can we ensure the general prosperity of the aviation sector in the EU and what's on the Commission's radar in the coming year(s).

Of course, these are just suggestions based on the group.
