Thank you for your email and apologies for getting back to you only now.

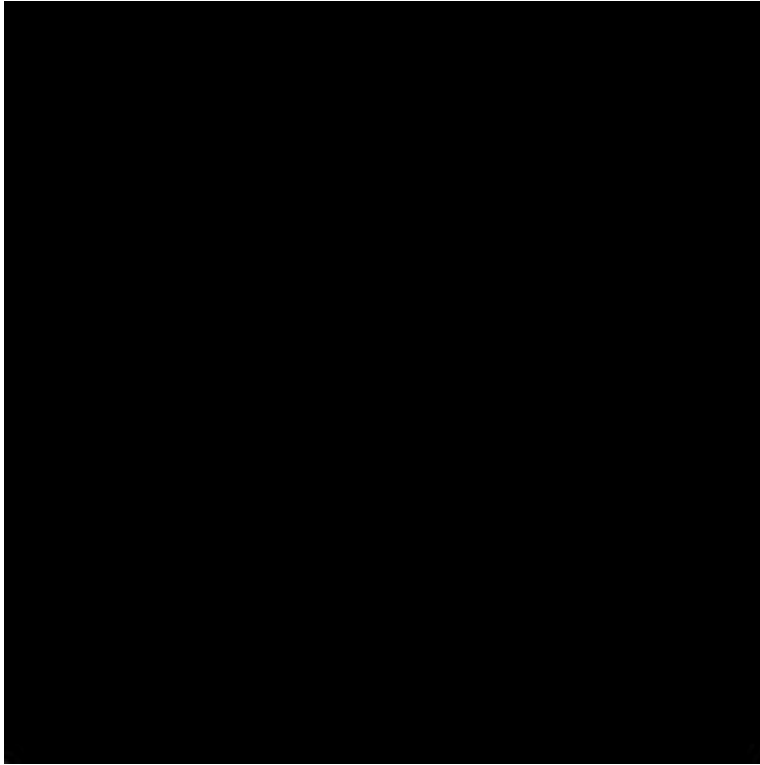

Commissioner for Energy. Together with all the other Members of the Commission, you have a unique role in shaping policies that will make a real difference in the lives of European citizens.

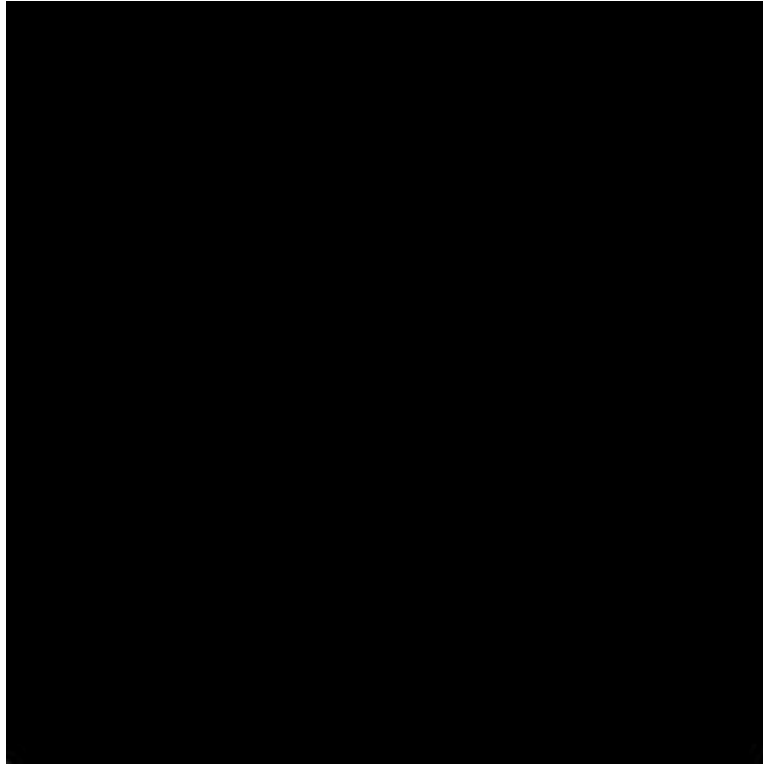

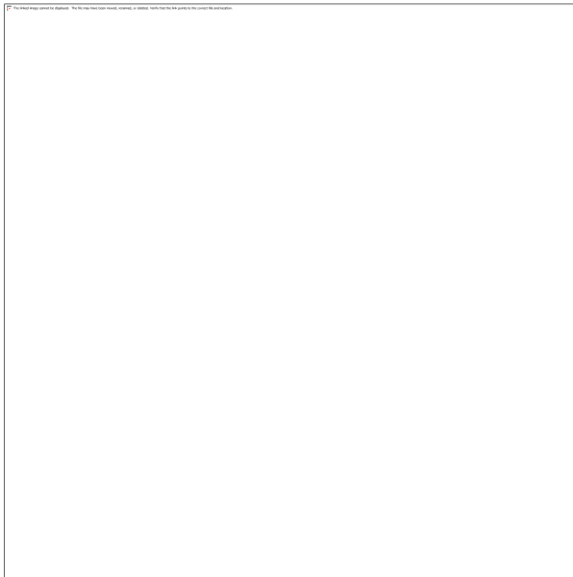
