Dear Ms Viviane Reding, Dear Ms Cecilia Malmström,

based on the Information on the web both of you care about childrens and parental rights as
- Commissioners for Justice, Fundamental rights and Citizenship and as
- Commissioner responsible for Home Affairs

I am contacting you in a private issue. It is re my son [REDACTED] who was brought on 19th of June 2009 to UK through his mother [REDACTED] (Nationality). I, the father have German nationality.

Based on a court decision in Malta (confirmed through the appeal court) I should have seen my child every month for 10 hours. In reality I have seen my child only once on 30th of October 2009 under very bad circumstances. Up to now I don't know where my child is. The mother has given a wrong adress when she moved to UK.

UK Lawyer and court have horrible expenses and the court is very

inefficient. After I have seen bills in the range of 15000 Euros I had to stop. I have contacted the Child Abduction Unit in London twice. Up to now I have not received an answer.

Additionally in Malta the family court judge [REDACTED] is not capable to make a decision (what he could have done latest on 25th of September 2009 when it was clear that the mother has give an wrong adress in UK).

Further, from the judge at the criminal court [REDACTED] in Malta there are very strong indications of corruption because he nominated a court case on 8th of February 2009. It was clear that the mother [REDACTED] (the case is against her) cannot be in Malta because there is a location order in UK. I did not go to Malta because I had several trips to Malta wasting time and money for trips. Further I knew that the mother will not be there so that he cannot go ahead. So he just closed the case. I have sent a letter to the minister of Justice in Malta a few weeks ago. Up to now now answer.

Finally I come to the following conclusions:

1. The United Kingdom (England) is not working according to what was agreed in Brussels II. That is the worst issue.
2. Malta Family court is avoiding a decision. They try to avoid that I can go to the ICHR in Strasbourg with this case.
3. Malta Criminal court - it is necessary to check if the legal process is according to the law.
4. Malta does not care data protection rights of a child.

If you need further information kindly let me know. Also I am willing to come to Brussels or Strasbourg to give you all the details in this case.

At the moment I add some papers to give you an idea about the case. I am fighting to see my child [REDACTED] who is 5 years old - since several years. Permanent the judges have failed to make fast and strong decisions.

I am aware that my child should be back in Malta end of April 2010. But I don believe this. And, when I see what is going on at catholic schools in Germany and Ireland I have the right and the Duty to get to know immediatley where my child is hidden. And under what circumstances.
