On behalf of the Dutch ombudsman for Children, [REDACTED] I write to you concerning the 9th forum on the rights of the child. [REDACTED] asked me to look into the possibilities for me to attend this forum, on behalf of the office of the Dutch Ombudsman for Children.

I have two reasons for this request. The Dutch ombudsman for children will be the next chair of ENOC (the European Network of Ombudspersons for Children).

As chair elect, we will host the annual conference of ENOC in September (22-24) in Amsterdam. The topic of the conference is Violence against children. At this moment we are also in the process of making a report on "Ending Violence in the EU".

Content report

Basis of the publications are the six strategies for action to prevent and respond to violence against children:

1. Supporting parents, caregivers and families
2. Helping children and adolescents manage risks and challenges
3. Changing attitudes and social norms that encourage violence and discrimination
4. Promoting and providing support services for children
5. Implementing laws and policies that protect children
6. Carrying out data collection and research

Within each strategy, the publications outline the current situation in EU member states regarding:

- the legal framework
- the policy framework
- the available services
- the equipment of professionals
- the impact of these frameworks & services


Consequently, the publications will contain:

- Facts about the prevalence of violence against children across the EU at home and in institutions.
- Key arguments for preventing violence (stressing the detrimental consequences for children & financial consequences for society)
- Overview of relevant international policies (European Commission; UN: Council of Europe)
- An overview of the current state of affairs across EU member states regarding the necessary range of protective measures according to the Committee on the Rights of the Child (prevention; identification; reporting; referral; investigation; treatment; follow-up; judicial involvement)
- Good practices across EU member states
- Concrete (legal) targets to be realized by 2020

It would be very helpful for me if I could attend the forum, because I am one of the researchers/authors of the report and I am also responsible for the ENOC-conference. All the extra information and input for the report will contribute to the quality and hopefully, to a better strategy in tackling violence against children in the EU.

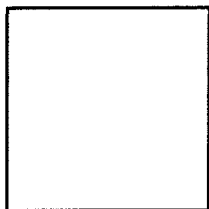

I would like to present our initiative with the following eight sentences:

- 1) PantallasAmigas (FriendlyScreens) is an organization with more than 10 years of experience focused on the positive use of (hence the name) technology to develop a responsible digital citizenship.
- 2) Originating from Spain, it has been echoed in many other countries, and inspired other initiatives worldwide to work with similar vision and goals
- 3) We put our focus on educative communication, the development of life skills, universal values and emotional education.
- 4) The topics addressed are especially cyberbullying, sexting and sextortion, cybersecurity and privacy.
- 5) We develop our own educational resources; among them: the educational cartoons (used on our YouTube channel with 43 000 followers: <http://www.youtube.com/user/pantallasamigas>) and the development of video games / apps
- 6) Two areas differentiate us in recent years:
 - a. We have a strong commitment in the fight against gender based cyberviolence.
 - b. We develop educational resources to promote and teach about the responsible use of internet for people with intellectual disabilities and Down syndrome
- 7) For 11 years we have defended the rights children have online as well, and we've been the only good practice during last February's safer Internet Day that gave voice to adolescents inviting them to talk in front of the Spanish government and other actors and companies related to the online/tech industry. Sarah Willoughby from EUN (sarah.willoughby@eun.org) included this action to this year's Safer Internet Day report.

Our resources are limited and are devoted to developing new ideas rather than communicate or advertise what we do and therefore only those who, knows our work closely value our work in the right measure.

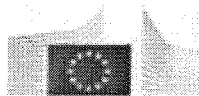

Since I'm doing a documentary on the EU Commissions work on children's rights, to cover this event is an important part in making the documentary.

I cannot believe that the Commission is adversed to media coverage, since visibility is in the interest of the European Commission.

Kindly revise your decision and allow me to cover this event.

Otherwise I see no other possibility than to turn to the Ombudsman, and certainly it will become part of the documentary, that the commission conducts such event's behind closed doors in secrecy.

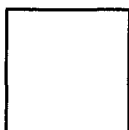

thank you for your prompt answer: I feel obliged to provide an equally prompt (and short) answer too.

To be honest, I was only surprised of having received a rejection without a justification to the application I made on behalf of my NGO "Associazione Figli Sottratti": I am an astrophysicist, and in my own professional environment we always provide evidence for any decision. I was definitely not disappointed!

The only reason why we decided to apply (as you can see I am cc-ing the Chairman of my ONG, [REDACTED] who forwarded the invitation to me as vice-chair), was that we are firmly convinced that one of the most fundamental childrens' right, i.e. the right to have two parents and two families (sect. 9 of the UN Convention on Childrens' Rights), is not regarded as a primary one in far too many countries, including many EC countries. A small example: in NONE of the events organised during 2014 to celebrate the anniversary (25 years) of the above mentioned Convention, this right was discussed.

Obviously the Organizers are free to decide the agenda of the Forum: however, we strongly believe that guaranteeing equal access to all parents and to their families of illegally abducted children (particularly within EC countries) is an important issue which deserves due consideration also in your event, because it definitely requires integration and coordination at political and judiciary levels.

Our main focus is not on counseling parents, but on childrens' fundamental rights.

For those of you who could not come to the informal consultation meeting we held this afternoon on the Forum:

At this stage we expect the theme of the Forum to be **integrated child protection systems** and to have guidelines published by end May as a staff working document.

We had in mind to structure the four Day 2 parallel sessions around Paras 45 ff GC No 13 (subject to further consultations, and agreement by management/our Commissioner), namely

- Session 1: Prevention measures
- Session 2: Identification, reporting, referral
- Session 3: Investigation, treatment, follow-up and judicial involvement
- Session 4: effective procedures

Those at the meeting thought this was fine and [REDACTED] suggested that we treat coordination and cooperation as a red thread throughout and look at how people work together across sectors and in the different processes.

This year, to foster greater coherence between the different sessions, the overarching theme could usefully be **coordination and cooperation**. Drawing on the findings of the FRA mapping and the public consultation on child protection systems, this is one of the biggest challenges that child protection systems face. It is relevant for practitioners at all levels and sectors, including inter-agency and inter-sectoral, and addresses cross-country cooperation and coordination. All four themes are meant to be broad, encompassing different concerns and actors, covering children in all situations in need of protection, bringing together stakeholders that are part of these different parts of the chain in child protection, to usefully learn from each other, to share good practice, and to ultimately stimulate cooperation and coordination.

1ST DAY – 3 JUNE

The first day of the Forum is a half-day and is dedicated to high-level interventions, including that of the Commissioner. These interventions could address both the broad theme of integrated child protection systems, and the forthcoming guidelines on integrated child protection systems (Staff Working Document).

2ND DAY – 4 JUNE

Similar to the Forums in 2012 and 2013, we have envisioned the second day to start with a high-level keynote speech in plenary. Most of the day is dedicated to four parallel sessions, followed by a plenary conclusion of the Forum.

All four themes are meant to be broad, encompassing different concerns and actors, covering children in all situations in need of protection, bringing together stakeholders that are part of these different parts of the

chain in child protection, to usefully learn from each other, to share good practice, and to ultimately stimulate cooperation and coordination.

We would prepare background papers for every session, etc. Do you have any comments or prefer to have a phone call on this?

We asked participants at the meeting, and would ask you too, to think about where you might like to make a contribution/suggest speakers/participants/panellists.
