The Committee has examined the Commission's request for an opinion on post-mandate activities Ms Vassiliou's wishes to pursue. In this Opinion, the Committee pronounces itself on invitations extended to Ms Vassiliou to become

and a Member of the Board of Trustees of the Cyprus Institute (Cyl) and the Cyprus Research and Educational Foundation (CREF).

The Committee takes note of the information provided by Ms Vassiliou in her notification of 9 February 2015 and by the Commission itself.

1.

2. <u>Board of Trustees of the Cyprus Institute (Cyl) and the Cyprus Research and Educational Foundation (CREF)</u>

- a. According to its web site, the Cyprus Institute (Cyl) "operates under the aegis of the Cyprus Research and Educational Foundation (CREF), which is governed by a Board of Trustees comprising leading personalities of the international academic, political and business worlds. The principal objectives of CREF are the advancement of knowledge and its humane and benevolent application and the establishment of a new research and educational public-benefit organization that shall generally promote research and education in Cyprus and abroad and aim primarily at benefitting the public interest at large".
- b. Among its objectives and achievements, the Cyprus Institute lists "strong collaborations with academic research organizations and strong links with industry internationally", "three licensed and accredited doctoral programs (by the Ministry of Education and Culture)", "outreach programs for education and community relations, focusing on the specific needs of Cyprus and the region", "engaging more than 130 scientists and professionals from around the world (...° with "faculty and researchers over 80% of the total staff" including "mainly EU nationals (over 10 different EU nationalities), but also nationals from other countries such as the United States, Russia and Egypt".
- c. The Committee notes that Ms Vassiliou's intended activity would not be remunerated. Although showing a link with the education dimension of Ms Vassiliou's former portfolio, the not for profit activities of the Cyprus Institute seem to be much wider, serve the public interest and support EU objectives in the field of research development at many levels, including reinforced cooperation with industry. The EU recognizes these efforts through FP7 funding selection (according to the Institute's web site).
- d. In view of the wider scope of the Cyprus Institute, its not for profit objectives in the public interest and the absence of remuneration for Ms Vassiliou's intended activity, the Committee sees no incompatibility with her former Commission mandate. Ms Vassiliou should, however, abstain from any activity, in particular lobbying, in case

the Cyprus Institute should wish to benefit from EU funding in all areas related to education and research.

Opinion:

The Ad-Hoc Ethical Committee is of the opinion that Ms Vassiliou's acceptance of the invitation to become Member of the Board of Trustees of the Cyprus Institute (Cyl) and the Cyprus Research and Educational Foundation (CREF) is compatible with the second paragraph of Article 245 of the TFEU.

Subject: Request from the European Commission of 9 March 2015, Ref. SG/B3 Ares(2015)2015, concerning post-office activities planned by former Commissioner Androulla Vassiliou.

- 1. The Committee has examined the Commission's request for an opinion on a postmandate activity Ms Vassiliou's wishes to pursue by accepting an invitation to become the official representative of Cyprus in the High Council of the European University Institute (EUI).
- 2. The Committee takes note of the information provided by Ms Vassiliou in her notification of 4 March 2015 and by the Commission itself. According to Ms Vassiliou's notification, the invitation has been extended to her by the President of the EUI in agreement with the Cyprus Minister of Education.
- 3. The Committee notes that the envisaged activity will be non-remunerated and that the Cypriot government will only cover

in the High Council's meetings.

- 4. According to the information provided by the Commission and by the web site of the EUI, the latter is an intergovernmental organization. The High Council is its Governing Board consisting of contracting Member states' representatives. It is responsible for the main guidance of the Institute and for drawing up the rules governing its activities. It adopts the budget and appoints the President and the Secretary General.
- 5. The EUI provides advanced academic training for doctoral researchers and promotes research in economics, history and civilization, law and the political and social sciences. Its doctoral programmes for the social sciences are amongst the most important in Europe, welcoming applicants from the EU, Switzerland, Norway and Turkey, eastern countries beyond the EU, the Mediterranean area and Latin America. The EUI is funded principally by contracting Member states and by the EU budget (respectively 44.1% and 17.3% in 2012: latest internet-accessible annual report of the EUI President).
- 6. The Committee has closely examined the direct link between Ms Vassiliou's former Commission portfolio and the envisaged EUI activity, as well the EU's budgetary contribution, which starts as a proposal from the European Commission with overall responsibility (and thus Ms Vassiliou's collegial co-responsibility) for the EU's budget execution.
- 7. However, the Committee is of the opinion that these elements of possible incompatibility our outweighed by (1) the not-for-profit, non-commercial, public service nature of the EUI's activities in support of Europe's academic and research ambitions, (2) the non-executive role of the High Council, (3) the absence of remuneration for Ms Vassiliou's envisaged activity, (4) the intergovernmental nature

of the EUI, principally funded by the contracting Member states and (5) Ms Vassiliou's public service support for the Cypriot authorities (Ministry of Education). Nevertheless, Ms Vassiliou should remain aware of her obligations as former Commissioner and abstain from any activity, e.g. related to EUI's requests for EU funds, contrary to the Code of Conduct for Commissioners.

Opinion:

The Ad-Hoc Ethical Committee is of the opinion that in accepting the invitation to become the official representative of Cyprus in the High Council of the European University Institute (EUI), Ms Vassiliou acts in accordance with the second paragraph of Article 245 of the TFEU.

- (1) to decide that Ms Vassiliou's non remunerated envisaged activity as Member of the Board of Trustees of the Cyprus Research and Educational Foundation is compatible with Article 245(2) of the TFEU on the condition that Ms Vassiliou refrains from any lobbying with the Commission and its services, during eighteen months after the end of her mandate as member of the Commission, should the Cyprus, Institute and/or the Cyprus Educational and Research Foundation decide to request any funding from the EU Budget.
- (4) to instruct the Secretary General to inform Ms Vassiliou about the present decision, yet drawing her attention to the condition contained therein.

Representative of Cyprus in the High Council of the European University Institute

The European University Institute (EUI) is an intergovernmental body created in 1972 by an international convention signed by the then six Member States of the European Communities, With time, 15 additional EU Member States signed the 1972 Convention.

The EUI is under the threefold authority of the High Council, the President of the Institute and the Academic Council. The High Council is the EUI's governing board. It consists of representatives from the Contracting States to the Institute's Convention.

Ms Vassiliou's activity will consist, upon appointment by the Cypriot Government, to represent the Republic of Cyprus within the EUI's High Council. Her activity will not be remunerated and the Cypriot Government will only cover

participating, twice per year, in

the High Council's meetings.

The Ad hoc Ethical Committee closely examined the link between Ms Vassiliou's former Commission portfolio and her envisaged activity with the EUI and considered that the Institute receives an EU budgetary contribution.

However, the Committee was of the opinion that these elements of possible incompatibility are outweighed by (1) the not-for-profit, non-commercial, public service nature of the EUI's activities in support of Europe's academic and research ambitions, (2) the non-executive role of the High Council, (3) the absence of remuneration for Ms Vassiliou's envisaged activity, (4) the intergovernmental nature of the EUI, principally funded by the contracting Member States and (5) Ms Vassiliou's public service support for the Cypriot authorities (Ministry of Education). The Committee came therefore to the conclusion that this activity is compatible with article 245(2) of the TFEU.

The Committee considered nevertheless that Ms Vassiliou should remain aware of her obligations as former Commissioner and abstain from any activity, e.g. related to EUI's requests for EU funds, contrary to the Code of Conduct for Commissioners.

While sharing the Ad hoc Ethical Committee's overall conclusion, the services of the Commission considered that Ms Vassiliou's role as the representative, in the EUI's High Council, of one of the Contracting Parties of the 1972 Convention will not expose her to any risk of conflicts with her obligations deriving from Article 245 (2) of the TFEU.

The Commission is invited:

- (1) to decide that Ms Vassiliou's non remunerated envisaged activity as Member of the Board of Trustees of the Cyprus Research and Educational Foundation is compatible with Article 245(2) of the TFEU on the condition that Ms Vassiliou refrains from any lobbying with the Commission and its services, during eighteen months after the end of her mandate as member of the Commission, should the Cyprus Institute and/or the Cyprus Educational and Research Foundation decide to request any funding from the EU Budget;
- (2) to decide that Ms Vassiliou's non remunerated envisaged activity as representative of the Republic of Cyprus at the High Council of the European University Institute is compatible with Article 245(2) of the TFEU;
- (3) to instruct the Secretary General to inform Ms Vassiliou about the present decision, yet drawing her attention to the condition contained therein as regard her activity with the Cyprus Research and Educational Foundation / Cyprus Institute.



Ms Vassiliou's activity will consist, upon appointment by the Cypriot Government, to represent the Republic of Cyprus within the EUI's High Council. Her activity will not be remunerated and the Cypriot Government will only cover

participating, twice per year, in

the High Council's meetings.

The Ad hoc Ethical Committee closely examined the link between Ms Vassiliou's former Commission portfolio and her envisaged activity with the EUI and considered that the Institute receives an EU budgetary contribution.

However, the Committee was of the opinion that these elements of possible incompatibility are outweighed by (1) the not-for-profit, non-commercial, public service nature of the EUI's activities in support of Europe's academic and research ambitions, (2) the non-executive role of the High Council, (3) the absence of remuneration for Ms Vassiliou's envisaged activity, (4) the intergovernmental nature of the EUI, principally funded by the contracting Member States and (5) Ms Vassiliou's public service support for the Cypriot authorities (Ministry of Education). The Committee came therefore to the conclusion that this activity is compatible with article 245(2) of the TFEU.



- (2) to decide that Ms Vassiliou's non remunerated envisaged activity as representative of the Republic of Cyprus at the High Council of the European University Institute is compatible with Article 245(2) of the TFEU;
- (3) to instruct the Secretary General to inform Ms Vassiliou about the present decision, yet drawing her attention to the condition contained therein as regards her activity with the Cyprus Research and Educational Foundation / Cyprus Institute.

The Commission shall examine the nature of the planned occupation and, if the activity is related to the content of the Commissioner's portfolio, it shall seek the opinion of the Ad hoc Ethical Committee.

On 9 February 2015, former Commissioner Androulla Vassiliou informed the Commission about her intention to accept a post mandate position as member of the Board of Trustees of the Cyprus Institute (CyI) and the Cyprus Research and Educational Foundation (CREF).

On 4 March, Ms Vassiliou informed the Commission about her wish to accept a non-remunerated assignment as the official representative of Cyprus in the High Council of the European University Institute.
