Dear Ms Paravicini,

We refer to your email dated 27 October 2015 in which you make a request for access to documents, registered under the above mentioned reference number.

As context, please take note that the Commission adopted in 2006 an EU strategy to support Member States in reducing alcohol-related harm. The Strategy addresses the adverse health effects related to harmful and hazardous alcohol consumption, as well as the related social and economic consequences. The role of the Committee on National Alcohol Policy and Action is the involvement in the process of coordinating government-driven policies aimed at reducing alcohol harm at national and local level, building on good practice identified in Commission's Communication COM(2006) 625 final.

Regarding your first question, please note that the members of this group have been appointed by the national authorities of their Member States (plus Norway, Switzerland and Liechtenstein). The mandate of the Committee on National Alcohol Policy and Action is attached.
