Thank you for your email.

Please find attached an updated programme and list of participants.

As you will see, the conference is very much attended by senior persons working in the bio-industries, particularly the bioethanol/biofuels industry, and other industries such as oil, farming, etc. The conference will be attended by approx 150 people, a large proportion of whom will be from ePURE member companies. In attendance will also be several European Commission and member state officials.

The conference itself is an annual policy conference that we organise for our members. It is a free to attend conference which is by invitation only. We typically invite persons from the various Brussels-based stakeholder groups that we work with throughout the year as well as various European policy makers.
