As regards your request related to ex-ante conditionalities apart from and in addition to those included in the proposal on the Common Provisions Regulation, it has to be noted that there are no other ex-ante conditionalities. Following the Council's partial general approach on ex-ante conditionalities (available on: http://register.consilium.europa.eu/pdf/en/12/st08/st08207-ad02re02.en12.pdf) and the mandate for opening interinstitutional negotiations adopted by the REGI Committee of the European Parliament (available on:

http://www.europarl.europa.eu/document/activities/cont/201212/20121211ATT57844/2012 1211ATT57844EN.pdf), trilogue discussions on ex-ante conditionalities are expected to start shortly. Guidance for Member States on ex-ante conditionalities is not yet available, but will be provided to Member States in due time.

Concerning your query on de-institutionalisation and the respect of the UN Convention on the rights of persons with disabilities, I would like to draw your attention to Annex V of the Commission's amended proposal for a Common Provisions Regulation (COM(2012)496 – available on Eur-Lex: http://eur-lex.europa.eu/Result.do?T1=V5&T2=2012&T3=496&RechType=RECH_naturel&Submit=Search),

and in particular to the ex-ante conditionality on active inclusion (which includes a criterion on de-institutionalisation) and the general ex-ante conditionality on disability (which requires the existence of a mechanism which ensures effective implementation and application of the UN Convention on the rights of persons with disabilities).
