In line with the Decree on the implementation of the Regulation (EC) of the EP and the Council on roaming on public mobile telephone networks within the Community AKOS can impose administrative fines on operators in case of infringements of Articles Regulation (EU) No 531/2012 on roaming on public mobile communications networks within the Union as amended by Regulation (EU) No 2015/2120 in the amount between 50.000 EUR and 125.000 EUR for telecommunications providers with yearly revenue above 200 million EUR, fines between 20.000 and 50.000 EUR in case of a yearly revenue between 50 and 200 million EUR, and fines between 10.000 EUR and 20.000 EUR in case of a yearly revenue below 50 million EUR. Moreover, the Decree provides for fines of responsible individuals in the companies ranging between 1.000 and 4.100 EUR.
