## ON NOTIFICATION ABOUT IMPLEMENTATION OF ARTICLE 6 OF REGULATION (EU) 2015/2120 OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL

The Communications Regulatory Authority of the Republic of Lithuania hereby notifies the European Commission of the national measures implementing Article 6 of the Regulation (EU) 2015/2120 of the European Parliament and of the Council of 25 November 2015 laying down measures concerning open internet access and amending Directive 2002/22/EC on universal service and users' rights relating to electronic communications networks and services and Regulation (EU) No 531/2012 on roaming on public mobile communications networks within the Union (hereinafter referred to as the Regulation).

Article 6 of the Regulation has been implemented in the Lithuanian national law by:

1) The Law No XII-1260 amending the Articles 26 and 74 of the Law No IX-2135 on Electronic Communications (hereinafter referred to as the Law). The Law came into force on 1 January 2015 and can be found (available only in the Lithuanian language) using the link below:

2) The Order No. 1V-462 of the Director of the Communications Regulatory Authority of the Republic of Lithuania of 20 April 2016 amending the Order No. 1V-293 of the Director of the Communications Regulatory Authority of the Republic of Lithuania of 16 September 2004 "On the Approval of the Rules for Imposition of Economic Sanctions" (hereinafter referred to as the Order No. 1V-293).
