- 4. Specific role that the partner organisation will play in this project (maximum 10 lines)

The University's research role in Northern Ireland will include analysis of legislation and policy regarding children of imprisoned parents and primary research based on qualitative interviews with key individuals and groups including legislators, sentencers, prison service officials and staff, professionals working in the prison system, representatives from non-governmental organisations, prisoners and their families, and collate and analyse available statistical material on children of prisoners. A report including recommendations will be produced. The team will facilitate dialogue involving criminal justice professionals and civil society on the issue of prisoners' children including the organisation of roundtables, seminars and a conference. The team will develop media work aimed at increasing the profile of the issue in the local media and enhancing public understanding of the 'silent sentence' served by the children and families of incarcerated people.

5. Reasons why the partner is suitable to play this role:

Dr Una Convery and Dr Linda Moore are both lecturers in criminology in the School of Policy Studies, University of Ulster. They have researched and published widely on the issue of the rights of detained people. They were the authors of two published reports for the Northern Ireland Human Rights Commission on the rights of children in custody. Dr Moore is also a co-author of two research reports for the Northern Ireland Human Rights Commission on the rights of women in custody. All of these reports were based on primary research conducted in the detention facilities (details provided in curriculum vitae). Dr Moore is also co-author of a report on children's rights in Northern Ireland published by the Northern Ireland Commissioner for Children and Young People. The work of the team at the University of Ulster will be supported by the involvement of Professor Phil Scraton, professor of criminology in the school of law, Queens University of Belfast. Professor Scraton is co-author of the NIHRC reports on women in custody with Dr Moore and co-author of the report on children's rights published by NICCY. He has published extensively on imprisonment and on children's rights. Professor Scraton is currently managing a major research

project based at Queens University Belfast on children, marginalisation and rights based on primary research with marginalised and socially excluded children and young people.

The research team has extensive experience of working with prisoners and with criminal justice agencies and has a wide range of contacts in the field. Dr Moore was recently legal advisor to criminal justice and victims working group of the Bill of Rights Forum and has provided consultancy to the Association for the Prevention of Torture (Geneva) on a project aimed at establishing monitoring systems for places of juvenile detention in Egypt.
