In Denmark we have issued a National Order to comply with article 29 in Regulation 2015/2283.

The Danish Order is:

"Bekendtgørelse nr. 1516 af 14. december 2017 om straffebestemmelser for overtrædelse af forordning om nye fødevarer, om ændring af Europa-Parlamentets og Rådets forordning (EU) nr. 1169/2011 og om ophævelse af Europa-Parlamentets og Rådets forordning (EF) nr. 258/97 og Kommissionens forordning (EF) nr. 1852/2001"

My English unofficial translation of the name of the Danish wording will be:

"National order no. 1516 from 14 December 2017 on penalties for non-compliance with Regulation (EU) 2015/2283 of the European Parliament and of the Council of 25 November 2015 on novel foods, amending Regulation (EU) No 1169/2011 of the European Parliament and of the Council and repealing Regulation (EC) No 258/97 of the European Parliament and of the Council and Commission Regulation (EC) No 1852/2001".
