## > Incident with Spanish NGO Proactive Open Arms

- The Ragusa judge decision (Decree) rejecting the seizure of the ship was discussed, including relevant parts such as the interpretation of the state of necessity (Art 54 of the Italian penal code) in relation to the assessment of Libya not qualifying as a place of safety/implementation of non refoulement principle. The decree also touched upon the Libya SAR area, not putting its legitimacy into question. Next steps at judicial level to be monitored closely.
