Dear Ms Da Silva,

We refer to your e-mail dated 25/04/2018 in which you make a request for access to documents, registered on 27/04/2018 under the above-mentioned reference number.

You request access to "documents which contain the following information:

- a list of lobby meetings held by DG JUST with Facebook or its intermediaries. The list should include: date, individuals attending + organisational affiliation, the issues discussed:
- minutes and other reports of these meetings;

all correspondence (i.e. any emails, correspondence or telephone call notes) between DG JUST (including the Commissioner and the Cabinet) and Facebook or any intermediaries representing its interests."

You further clarified by your email of 18/05/2018 addressed to DG JUST that you are interested in documents from 01/11/2014 onwards and that the research can be limited to meetings with Facebook directly. Thereby, we consider your request to cover documents held up to the date of your initial application.

Given that you submitted the same request to other Directorates-General of the Commission as well, this reply relates only to the documents held by DG JUST. You received or will receive the replies from the other respective Directorates-General in due course.

I would also like to inform you that in order to identify the meetings falling under your request I have used the definition of lobbying activities as described in the Commission

Communication of 21 March 2007¹ as "all activities carried out with the objective of influencing the policy formulation and decision-making processes of the European institutions", accepted also by the European Parliament in the EP resolution of Thursday 8 May 2008, concerning a "Framework for the activities of lobbyists in the EU institutions²"

You will find a copy of all these documents attached to the present letter, except documents n. 11 and 13. Since these documents originate from a third party, the originator of the documents has been consulted. We are waiting for the observations of the author of documents and you will receive an additional reply by the 23rd of July 2018.

Furthermore, concerning documents 2 and 4, some sections have been redacted as they do not refer to meetings with Facebook. These sections are therefore outside the scope of your request and they redaction does not represent a refusal of access.

The documents to which you have requested access contain personal data, in particular names and contact details of non-senior management staff.

Pursuant to Article 4(1) (b) of Regulation (EC) No 1049/2001, access to a document has to be refused if its disclosure would undermine the protection of privacy and the integrity of the individual, in particular in accordance with Community legislation regarding the protection of personal data. The applicable legislation in this field is Regulation (EC) No 45/2001 of the European Parliament and of the Council of 18 December 2000 on the protection of individuals with regard to the processing of personal data by the Community institutions and bodies and on the free movement of such data³.

When access is requested to documents containing personal data, Regulation (EC) No 45/2001 becomes fully applicable⁴.

According to Article 8(b) of this Regulation, personal data shall only be transferred to recipients if they establish the necessity of having the data transferred to them and if there is no reason to assume that the legitimate rights of the persons concerned might be prejudiced.

We consider that, with the information available, the necessity of disclosing the aforementioned personal data to you has not been established and/or that it cannot be assumed that such disclosure would not prejudice the legitimate rights of the persons concerned. Therefore, we are disclosing a version of the documents requested in which these personal data have been redacted.

Please note that some documents were received by the Commission from third parties. They are disclosed for information only and cannot be re-used without the agreement of the originator, who holds a copyright on them. They do not reflect the position of the Commission and cannot be quoted as such.

Concerning the minutes or the summary record of meetings, please note that these documents were drawn up for internal use under the responsibility of the relevant services of DG JUST. They solely reflect the services' interpretation of the interventions made and do not set out any official position of the third parties to which the documents refer, which were not consulted on its content. They do not reflect the position of the Commission and cannot be quoted as such.

In case you would disagree with the assessment that the redacted data are personal data, which can only be disclosed if such disclosure is legitimate under the applicable rules on the protection of personal data, you are entitled, in accordance with Article 7(2) of Regulation 1049/2001, to make a confirmatory application requesting the Commission to review this position.
