National authorities, however, might still enforce national rules as they stand (not yet adapted to the Directive). In case of subsequent court proceedings, the concerned person (who might have, for example, received a fine), may invoke a Directive having directive effect before court.

In short: An expired transposition deadline does not lead to an authorisation. It's the national law which is still relevant. National enforcement authorities might be enforcing current national law, even if the transposition deadline of the Directive has passed.
