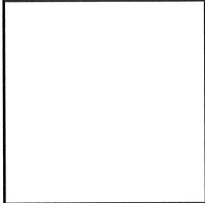

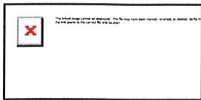

The purpose of this meeting would be to discuss and have an exchange of views on several topics such as:

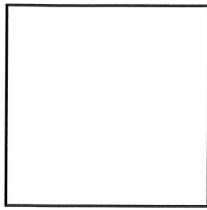
- The collective and individual contribution of banks to **Sustainable Finance** (from EBF and BBVA's perspective);
