1. Use of cameras by paramedics

One of the expert subgroup members asked for the groups' experiences on the use of cameras by paramedics in the course of their functions. One member of the expert subgroup explained that it has a general law forbidding surveillance at work. Can use videocameras for other purposes, such as security, but if it could indirectly monitor the activity of the employees, it is necessary to adopt some guarantees, like an approval from the unions. Have some cases of companies installing these systems for security purposes. Indicated willingness to share these provisions. Another member of the expert subgroup made references to its published guidelines on Google's glasses. The members of the expert subgroup agreed to share information on this subject.
