1. Adoption of the Agenda and minutes of last meeting

2. Follow-up to the EDPB Plenary meetings

The previous Plenary gave a mandate to the Cooperation subgroup to work on guidelines on how to proceed with cases under cooperation and consistency procedures in case of no-deal Brexit.

The existing mandate on local cases was expanded to cover the section of the draft guidelines which address a number of preliminary steps and concepts that are relevant for case handling in general.

3. Presentation of the new cooperation tool, Confluence

The SEC presents Confluence, the tool to serve as knowledge base, as requested by the Cooperation ESG. The IT users ESG accepted Confluence as the best tool available for this purpose. The Plenary still needs to endorse Confluence, which is expected to happen at the March Plenary. The current plan is to go live in April. All members of the Cooperation ESG are invited to provide feedback today or after the meeting.
