THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU, Euratom) 2018/1046 of the European Parliament and of the Council of 18 July 2018 on the financial rules applicable to the general budget of the Union, amending Regulations (EU) No 1296/2013, (EU) No 1301/2013, (EU) No 1303/2013, (EU) No 1304/2013, (EU) No 1309/2013, (EU) No 1316/2013, (EU) No 223/2014, (EU) No 283/2014, and Decision No 541/2014/EU and repealing Regulation (EU, Euratom) No 966/2012 (hereafter the ‘Financial Regulation’)¹, and in particular Article 200(6) thereof,

Whereas:

- (1) In the framework of the Horizon 2020 Programme², in accordance with the Work Programme 2018-2020³ the call H2020-INFRAIA-2018-2020 was published on 27 October 2017 – with deadline for submission by 22 March 2018.
- (2) The proposals received were evaluated and ranked in accordance with Article 200 of the Financial Regulation and the following special provisions: Articles 14 and 15 of the H2020 Rules for Participation.
- (3) Following this evaluation (and having regard to the available budget), a call ranked list was drawn up with the proposals to be invited to grant preparation.
- (4) During grant preparation, further checks were undertaken on double funding, ethics, operational and financial capacity and non-exclusion.
- (5) This Decision concerns successful proposals which – under Article 5(7) of the H2020 Specific Programme Decision – require a Commission award decision in *mode décisionnel*.
- (6) Such decisions have been delegated by Commission Decision C(2014) 7046 of 1 October 2014 to the Director-General(s) that are competent for implementing the Horizon 2020 Programme.

The following service will be competent for the budget implementation:

- Directorate-General for Research and Innovation (RTD)

- (7) In accordance with the procedure referred to in Article 5(7) of the H2020 Specific Programme Decision, the programme committee was consulted on the proposal(s) that should be funded. The measures provided for in this Decision are in accordance with the opinion of this programme committee.
- (8) As a result, the proposal listed in the Annex should be funded,
