In your request, you do not express any particular interest to have access to these personal data nor do you put forward any arguments to establish the necessity to have the data transmitted for a specific purpose in the public interest.

Documents not existing

For documents n° 5 and 8, the services of the Directorate General for Energy ("DG Energy") consulted the Cabinet of Commissioner Simson. The result of this search is that no documents could be found that would correspond to the description in your request.

As specified in Article 2(3) of Regulation (EC) No 1049/2001, the right of access as defined in that regulation applies only to existing documents in the possession of the institution.

Given that no such documents, corresponding to the description given in your application, are held by the Commission, the Commission is not in a position to fulfil your request.
