Subject: Your application for access to documents – **GESTDEM 2020/1279**

We refer to your e-mail of 2 March 2020 in which you make a request for access to documents, registered on 4 March 2020 under the above-mentioned reference number.

You request access to all documents - including but not limited to minutes, (handwritten) notes, audio recordings, verbatim reports, operational conclusions, lines to take, briefings, e-mails, and presentations - related to specific meetings of Executive Vice-President Frans Timmermans with different stakeholder groups over the period December 2019 to February 2020, which you have identified.

Please note that due to the wide scope of your request, covering also areas falling under the responsibility of other Directorates-General, parts of your request have been attributed to Directorate-General Climate Action, under **Gestdem reference 2020/1301**.

This reply relates only to the documents held by the Secretariat-General.

the legitimate interests of the data subject might be prejudiced. In your request, you do not express any particular interest to have access to these personal data nor do you put forward any arguments to establish the necessity to have the data transmitted for a specific purpose in the public interest.

Consequently, I conclude that, pursuant to Article 4(1)(b) of Regulation (EC) No 1049/2001, access cannot be granted to the personal data contained in the requested documents, as the need to obtain access thereto for a purpose in the public interest has not been substantiated and there is no reason to think that the legitimate interests of the individuals concerned would not be prejudiced by disclosure of the personal data concerned.
