With regard to all the documents listed above, a complete disclosure of the identified documents is prevented by the exception concerning the protection of privacy and the integrity of the individual outlined in Article 4(1)(b) of Regulation (EC) No 1049/2001, because they contain the following personal data:

- the names/initials and contact information of Commission staff members not pertaining to the senior management;

- the names/initials and contact details of other natural persons;
- handwritten signatures/abbreviated signatures of natural persons.

Moreover, since document "Ares(2020)2355962 Basel III Implementation issues Feb 2020 final" comes from a third party, the originator of the document has been consulted.

Following an examination of document "Ares(2020)2355962 Basel III Implementation issues Feb 2020 final" under the provisions of Regulation (EC) No 1049/2001 regarding public access to documents and taking into account the opinion of the third party, I regret to inform you that your application cannot be granted, as disclosure is prevented by exception to the right of access laid down in Article 4 and first indent of Article 4(2) of this Regulation.

The document which you seek to obtain contains commercially sensitive business information of the company that submitted it. The authors of the document have objected to the disclosure of the document that they sent to the Commission and have motivated their position by explaining that its disclosure would impact negatively their intellectual property, as defined under Article 4(2) of the Regulation. We have considered whether partial access could be granted to the document requested but it is entirely covered by the exception under Article 4(2) of the Regulation.

The exceptions laid down in Article 4(2) and 4(3) of Regulation (EC) No 1049/2001 apply unless there is an overriding public interest in disclosure of the document. We have examined whether there could be an overriding public interest in disclosure, but have not been able to identify such an interest.

In accordance with Article 7(2) of Regulation (EC) No 1049/2001, you are entitled to make a confirmatory application requesting the Commission to review this position.

Such a confirmatory application should be addressed within 15 working days upon receipt of this letter to the Secretary-General of the Commission at the following address:
