Dear Mr Nielsen,

We refer to your e-mail dated 13 July 2020 in which you make a request for access to documents, registered on the same date under the above-mentioned reference number. We also refer to our e-mail of 31 July 2020 through which the time limit for handling your application has been extended by 15 working days, in accordance with article 7(3) of Regulation (EC) No 1049/2001¹. We apologise for the delay in replying to you.

You request access to all the documents that served as a basis for obtaining the conclusions of the Commission's Report on the implementation of the European Fund for Sustainable Development (hereafter "the report"). You indicate that "[T]his includes, but is not limited to:

- All correspondence – including all attachments – regarding, mentioning or discussing the Relevance, Effectiveness and value added, Efficiency, Coherence and co-ordination, Sustainability.

- A list of all meetings held where these conclusions were discussed or mentioned, as well as all minutes of these meetings".

As a preliminary remark, we would like to draw your attention to the fact that the conclusions of the report referred to in your request are based on the results and analysis provided in the external study that was commissioned for this purpose and which was published alongside with the Commission's report², including the methodology and list of documents provided in annexes 2 and 3.
