1. COARM work programme for 2013

Further to the discussion at directors level on 17 December 2012 and to comments received, the Group will discuss the revised COARM work programme for 2013 circulated under COARM MD 001/13.

2. Information exchange regarding export policies

(i) Exchange of views on export policies DELETED (cf. DELETED/0175/12)

The Group will exchange views and updates regarding export policies DELETED, based on the DELETED request outlined in DELETED/0175/12.

With a view to informing the discussion in the Group, delegations are invited to circulate in writing, ahead of the meeting, information on their arms export policies DELETED focusing on the assessment of the most relevant criteria identified in the DELETED request and on licences granted over the past 15 months.

In preparing their oral and written contributions to the discussion under this agenda item, delegations are strongly encouraged to apply the dedicated guidelines on the information exchange on specific destinations as agreed by COARM (cf. EAS/0867/12).

(ii) Possible update on recent key developments of national export policies

Delegations will have the opportunity to update the group about the state of play of their domestic export control policy reviews as well as on any possible suspension/revocation policies vis-à-vis specific destinations (cf. point 4 of the guidelines on the information exchange on specific destinations - EAS/0867/12).

3. Review of Common Position 2008/944/CFSP

The Group will continue the discussion on the application of criteria 7 and 8 and the improvement of the denial information exchange (cf interim guidelines in Coreu EAS to be circulated ahead of the meeting).

Based on the roadmap contained in the Review Food-for-Thought paper endorsed by COARM (cf EAS/0785/12), the Group will also address the two following issues where first reactions from delegations will be sought:
