**I. DRAFT ANNOTATED AGENDA**

**1. Council decision authorising the ATT ratification**

With a view to the hearing to be held by the INTA Committee on the ATT on 16 December 2013, delegations will have the opportunity to inform on the state of play of their domestic ratification process and their degree of readiness to deposit their instrument of ratification.

**2. Contacts with third countries and other stakeholders and national outreach and assistance activities in support of the ATT process**

*i) Contacts with third countries and other stakeholders*

Delegations will be invited to share information on recent consultations on ATT with third countries and other stakeholders.

*ii) National outreach and assistance activities*

Delegations will be invited to exchange information on any outreach and assistance activities they engage in nationally.

**3. Paper on EU's future role in ATT-related outreach and assistance**

The Group will have the opportunity to discuss the draft 20 page paper on the EU's future role in ATT-related outreach and assistance as foreseen by Council Decision 2013/43/CFSP and circulated under COARM MD 51/2013.

**4. Draft Council decision on EU activities in support of the implementation of the Arms Trade Treaty**

The Group will be updated on the adoption process (ST 15352/13).

**5. ATT Resolution in the UNGA**

The Group will have the opportunity to share assessments regarding the vote by the UNGA of the ATT Resolution.

**6. EU demarche in support of the ATT/ Terms of reference for the second part**

Based on a draft to be circulated ahead of the meeting, the Group will discuss the ToR for the second part of the EU demarche expected to be carried out in January 2014 towards countries that abstained at the vote adopting the Treaty in April 2013.

## **7. ATT Secretariat**

Further to the circulation of meeting document 50/2013 and to comments received (**DELETED** 094/13), delegations will revert to issues relating to the ATT secretariat.

## **8. Merging ATT agenda item into COARM**

Further to the agreement in principle to merge the ATT agenda into the regular agenda of COARM and based on an information note to be circulated ahead of the meeting, the Group will address the practical issues raised by the merging with a view to formally agreeing the end of the COARM/CODUN on ATT as a stand-alone working party.

## **9. Inclusion of ATT language in a standard clause to be proposed in agreements between the EU and third countries (tbc)**

Further to the discussion at the November 2013 CODUN, the Group may have a first discussion on a draft text for such a clause.

## **10. Preparations for the annual CODUN CONOP COARM Directors meeting and the EU-28 Dialogue with the US**

The Group will have an exchange of views on preparations for the meetings of the CODUN CONOP COARM Directors scheduled for 12 December and the EU28-US dialogue scheduled for 13 December 2013 since both meetings will address the ATT.
