Pursuant to Article 4(6) of the Regulation, access can be granted to these documents with the exception of some parts which contain internal considerations and opinions drawn up for internal use only, with a view to the discussions in the working party. Some other parts relate to internal opinions regarding relations with third parties. These assessment are merely of an internal nature. Disclosure of these parts would seriously undermine the decision-making process. It would also complicate the EU's political relationship with those third parties and adversely affect the EU's international relations.

Access to these parts of the documents must therefore be refused on the basis of Article 4(1)(a), third indent of the Regulation (protection of the public interest as regards international relations) and in the absence of any evidence of an overriding public interest in release also pursuant to the first and second subparagraph of Article 4(3) of the Regulation (protection of the decision-making process of the Council).

You will find the redacted version of these documents enclosed.

Should you wish this position to be reviewed you may write to the EEAS at the address below, confirming your initial request. You have fifteen working days in which to do so from receipt of this letter, after which your initial request will be deemed to have been satisfied.

The EEAS would inform you of the result of this review within fifteen working days from the registration of your request, either granting you access to the documents or confirming the refusal. In the latter case, you would be informed of how you can take further action.
