On the urgency of the slot waiver, I would like to propose a follow up discussion between Redacted and our CEO Redacted. Again, we want to emphasize that an early waiver will be beneficial for all stakeholders and in particular will allow airlines to give up as soon as possible the slots they already know they do not need in the Winter season. Having to hold on slots is in nobody's interest and actually costs airlines a huge amount of money.

This is the message that Redacted would like to illustrate with the information he gets daily from our member airlines.
