EIT – EIT InnoEnergy Framework Partnership Agreement 2016

Amendment No. 7

Contract No. FPA2016/EIT/EIT InnoEnergy

The **European Institute of Innovation and Technology ('the EIT')**, represented for the purposes of signature of this Amendment to the Framework Partnership Agreement by its Interim Director Martin KERN,

and

on the other part,

1. The Knowledge and Innovation Community Legal Entity ('the KIC LE'):

KIC InnoEnergy SE ('KIC InnoEnergy') a Societas Europea duly incorporated under the Laws of The Netherlands with registered office located at the John F. Kennedylaan 2 6E Verdieping, 5612 AB Eindhoven, The Netherlands, registered in the Trade Chamber of Eindhoven under the number 51418886, represented for the purpose of signing the Amendment by its CEO Diego PAVIA, hereinafter referred to as the "**KIC LE**".

2. and the other Knowledge and Innovation Community ('KIC') Partners listed in Annex 2 of the Framework Partnership Agreement, represented for the purposes of signing the Amendment by the KIC LE (see the mandate in Annex 4 of the Framework Partnership Agreement and Article 62 of the Framework Partnership Agreement).

Having regard to the Framework Partnership Agreement (Contract No. FPA2016/EIT/KIC InnoEnergy), concluded on 07 March 2016, hereinafter referred to as FPA2016/EIT/KIC InnoEnergy,

Whereas,

- 1) The Horizon 2020 model Framework Partnership Agreement and model Specific Grant Agreement are subject to regular updates by the European Commission;
- 2) It is important to incorporate these changes in the grant agreements signed by the EIT with the Knowledge and Innovation Communities;
- 3) On 12 October 2017 the EIT sent to the KICs the updated text of the Framework Partnership Agreement and Specific Grant Agreement, their Annexes and three explanatory notes clarifying the most important changes in line with updates of the Horizon 2020 model agreements;
- 4) On 20 December 2017 the EIT sent to the KICs the final consolidated text of the Framework Partnership Agreement and Specific Grant Agreement and their Annexes;
- 5) The EIT was informed in writing that the shareholders of KIC InnoEnergy SE have given their approval to the Amendment on 27 April 2018;
- 6) KIC InnoEnergy notified the EIT of the change of its official address;
- 7) The text of FPA2016/EIT/KIC InnoEnergy should therefore be amended accordingly.

HAVE AGREED AS FOLLOWS

Article 1

The new official address of the KIC LE (i.e. John F. Kennedylaan 2 6E Verdieping, 5612 AB Eindhoven, The Netherlands) shall replace the old address in the incipit of FPA2016/EIT/KIC InnoEnergy.

Article 2

- (1) The consolidated text of the updated Framework Partnership Agreement, enclosed to the present Amendment as Annex 1, shall replace the text of FPA2016/EIT/KIC InnoEnergy.
- (2) Annex 1 (Strategic Agenda), Annex 2 (List of KIC Partners) and Annex 5 (List of Linked Third Parties) of FPA2016/EIT/KIC InnoEnergy shall remain unchanged and shall continue to apply.
- (3) Annex 3 (Model Specific Agreement and its Annexes), Annex 4 (Model Accession form), Annex 6 (Model for the Certificate on the Methodology) of FPA2016/EIT/KIC InnoEnergy shall be replaced by Annexes 2, 3 and 5 of the present Amendment.
- (4) New Annex 4a (Declaration on joint and several liability of linked third parties) and new Annex 7 (List of International Partners), enclosed to the present Amendment as Annexes 4 and 6 shall become part of FPA2016/EIT/KIC InnoEnergy.

Article 3

The present Amendment shall enter into force on the day of signature by the EIT or the KIC LE, depending on which is later.
