1&1 by Ionos (Germany, around 2000 employees) is a web hosting and cloud partner targeting small and medium-sized businesses, focusing on IaaS and offer a portfolio of solutions for the digital space. 3Ds Outscale (Gaia-X Founding member)



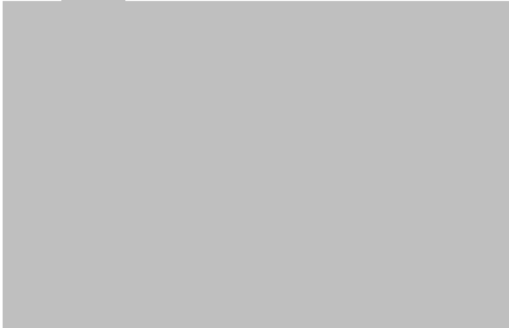

Amadeus (Spain, around 17 000 employees) is a technology company dedicated to the world's travel industry. The company has a team across the world in more than 190 countries. They deliver technology solutions at all stages of the travel experience – from inspiration to shopping, booking, on-trip and post-trip.

In The Netherlands, Ocom is market leader in bare metal servers and cloud. It is a leading force in Europe in 'green hosting' and can build on top connectivity services as it is located on the Amsterdam Internet Exchange Point. Ocom can deliver large bandwidth over its network, as it transports 5 Tbps over the internet. **Leaseweb** operates a network with data centers around the globe, incorporating 43 points of presence and 29 Internet Exchanges around the globe.

Magic Cloud Oy
