thank you for your availability to consider our request to deepen the issue of the ETS State Aid Guidelines with your cabinet.

As you are aware the ETS State Aid Guidelines are under review and the European Commission has recently closed the public consultation on this topic, in which Cerame-

Unie has also participated (please see attached our reply to the consultation).

We are particularly concerned about the sector of wall and floor tiles (NACE code 2331), which to our belief, must be included in the eligibility list for the indirect cost compensations, as exposed to the indirect carbon leakage risk. The additional information verified by PwC and submitted by Cerame-Unie under the consultation substantiates the call for a methodology better taking into account the specificities of SME sectors which are more labour intensive.

We would appreciate having the possibility during a conference call to present to you the additional information provided during the consultation on the draft ETS State Aid Guidelines.
