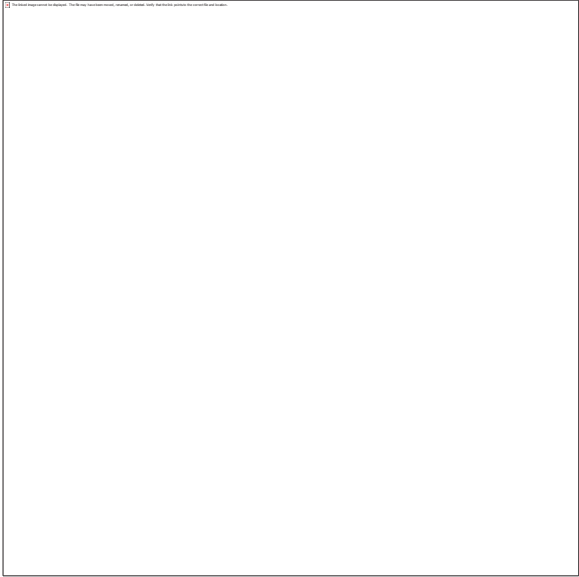

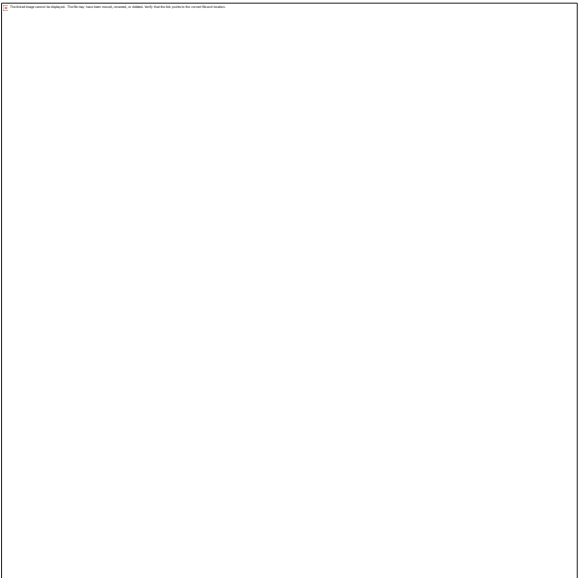

I am contacting you regarding our pending meeting with Mr Rossides scheduled before the COVID-19 outbreak.

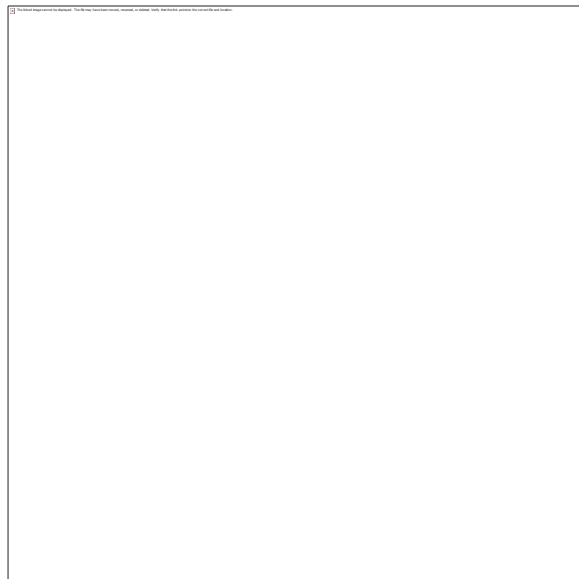
