Thank you (and your colleagues) so much for our meeting last Tuesday. We really appreciated your willingness to meet with us despite this very busy period.

We look forward to engaging with you and with the Executive Vice-President Vestager during this new legislative term. As discussed at our meeting there are different platforms that we could propose for the Executive Vice-President to share her priorities and have a discussion with business to get feedback and discuss with business.
