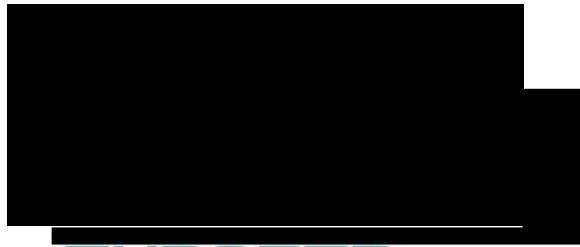
This is an urgent and important request considering the crucial situation of our sector.
